A. Consider approving three (3) 1-Day Class F1 Liquor Licenses (Full Privilege), and a Carnival License for the Portuguese American Social & Athletic Club of Georgiaville for the Annual Holy Ghost Feast to be held on July 29<sup>th</sup>, 30<sup>th</sup>, and 31<sup>st</sup>, 2005 on club grounds located at 32 Fenwood Avenue pending compliance with all state regulations and local ordinances and subject to conditions set forth in an agreement between the Portuguese American Club and the Smithfield Police Department signed June 22<sup>nd</sup>, 2005 which addresses crowd control and the sale, possession and

consumption of alcoholic beverages. Fee waived for Carnival License only.
