Proposed amendment to reflect allowable fuels, prohibited fuels, heating season, permit process, and operating restrictions on location, installation, and use.

Proposed Ordinance Amendment

Chapter 204: Flood Damage Prevention

Proposed amendment to reflect adoption of floodplain management regulations that meet the National Flood Insurance Act/Program's comprehensive set of standards found in NFIP paragraph 60.3(d), to include: change to Flood hazard protection; delete Building Official; add Environmental Affairs Officer; delete reference to Coastal Resource Management Council and coastal V-Zones, and add \$100 per day past due fine until violation is corrected.
